7. Handling and storage

Precautions for safe handling	Keep away from strong acids. Provide appropriate exhaust ventilation at places where dust is formed. Minimize dust generation and accumulation. Avoid breathing dust. Avoid contact with eyes. Practice good housekeeping. Avoid contact with water and moisture.
Conditions for safe storage, including any incompatibilities	Store in original tightly closed container. Store in a well-ventilated place.
